Every participant is personally responsible for organising a suitable flight to Iceland, return transfer from Keflavik Airport to Reykjavik BSI bus terminal and, if applicable, additional accommodation.

Terms and conditions

By booking this tour the customer accepts the following conditions.

1. Conditions of payment

The participant is obligated to make a deposit of ISK 97'000.- (1/3 of the full tour price) upon booking. The balance of ISK 193'000.- is to be transferred by 30/04/2018. Failure to comply with this deadline will result in forfeiture of the deposit and the place on the tour will be made available to another rider.

Any charges for bank transfers shall be borne by the applicant.

2. Cancellation policy, appointment of replacement participants

- Withdrawal from the contract or not attending the tour without withdrawing from the contract will incur a cancellation fee. The amount is dependent on the time of cancellation. The participant will be charged for any costs that have incurred effectively by the time of cancellation and that cannot be reclaimed by Hestaferðir Stóra Kálfalæk 2, in addition to a service charge of ISK 10'000.00.
- Where cancellation occurs after confirmation of the tour with involved parties and tour participants and where booked services must be provided, there will be no refund of costs and the participant is obligated to pay any outstanding down-payments.
- Until the start of the tour, the participant is entitled to appoint a replacement person who is willing to accept the rights and duties of the tour contract and who meets the requirements of the tour with regard to riding ability. Hestaferðir Stóra Kálfalæk 2 is authorised to object to the appointment of the third party if they do not comply with the specific requirements of the tour or if the appointment is in conflict with legal regulations or official orders. In case of a third party entering the contract the participant and the third party shall be liable as joint debtors for the cost of the tour and for any additional costs incurred by the appointment of the third party.

3. Confirmation of Insurance

By booking this tour the participant confirms that they have valid travel insurance and accident insurance which covers events occurring in Iceland.
